### What is a Sprint Enduro?

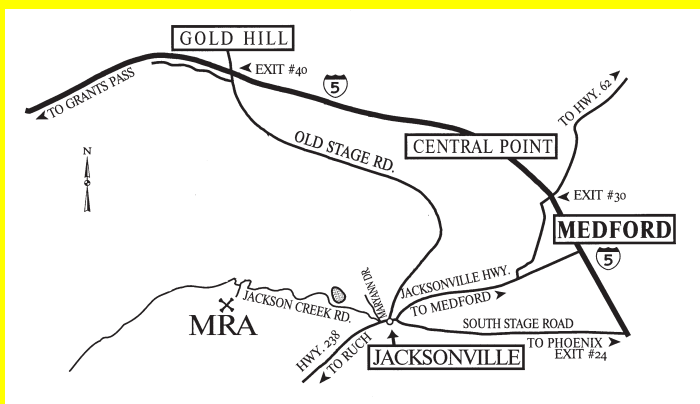
