- On-line pre-entry available on MRA's website

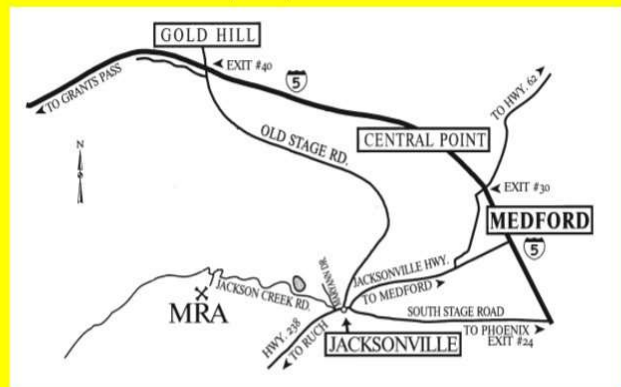

Knowing the risks of motorcycle racing, nevertheless, I hereby agree to assume those risks and to release and hold harmless all the persons or entities mentioned above who (through negligence or carelessness) might be liable to me (or my heirs or assigns) for damages.

It is further understood and agreed that this "Waiver, Release And Assumption Of Risks" to be binding on my heirs and assigns.
